| <b>Why a Cookie Policy?</b>       | <p>It is also our legal obligation to obtain your consent for us to use cookies. Consent needs to be free and informed. Thus, it is our legal obligation to tell you:</p> <ul style="list-style-type: none"><li>• That we use cookies;</li><li>• What cookies are doing;</li><li>• How long cookies last.</li></ul>   |
| <b>What Are Cookies?</b>          | <p>Cookies are small text files which our website will transfer to your computer, mobile phone or other device to allow you to use the website.</p> <p>We use 'session cookies' to maintain your website use during a session.</p> <p>These cookies are not used to identify you personally, or to hold any personal data.</p> <p>If you disable or restrict session cookies, you may not be able to make full use of our website.</p>  |
| <b>How Long are Cookies Kept?</b> | <p>Session cookies are removed after a session ends.</p> <p>A session ends when you close your browser or after a period of 30 minutes of inactivity.</p> <p>In the case of some pages (i.e. Open Trades, Expired Trades, Trades and Market), these being updated every 30 seconds, the session effectively does not expire until you, as user, either close the Web page tab or close the browser.</p> <p>There is only one temporary cookie, which does not last the time of a session but just the time to transfer data from one page to another.</p> <p>This is to change the Registration form. The Consent is on another page and will have to be temporarily stored locally in a sessionStorage object with ALL the data filled in in the previous part of the form, i.e. Forename, Last Name, Date of Birth, email, password, Address etc.</p> <ul style="list-style-type: none"><li>• This cookie will be deleted on submission of the Registration form.</li></ul> |
